Motion made by Mrs. McKenna and seconded by Mrs. Powers to approve the March 8, 2016 executive session School Committee minutes. Voted 6-0 unanimously

Mrs. Kuechler announced the open Public Hearing of the FY'17 Budget. Dr. Baldwin informed the School Committee that the proposed FY'17 budget figure represented a 3.5% increase from the FY'16 budget. The FY 2017 Preliminary Draft Figure presented to the Fairhaven School Committee was \$19,385,788.

Mrs. Kuechler invited the public to ask questions. Mrs. Diane Hahn approached the podium and stated her opinion about the student services plan. Mr. Furtado, asked Dr. Baldwin regarding teachers being allowed to bring their non-resident students to school in Fairhaven. Dr. Baldwin explained that there is a clause in the contract that allows decisions to be made based on class sizes.

Motion made by Mr. Veitch and seconded by Mrs. Powers to close the public hearing on the FY'17 Budget. Voted 6-0 unanimously

Motion made by Mr. Veitch and seconded by Mr. Monroe to re-adjourn the regular School Committee meeting. Voted 6-0 unanimously
