Minutes

Financial Report

The Chairman read the financial report.

Chairman's report

Chairman Oliveira updated the commission regarding the Community Preservation Committee (CPC) proposed projects.

Mr. Oliveira reported to the commission that he will be submitting an article for the May 2021 Annual Town Meeting for funding the period correct street lamps around the Town Hall. (Attachment A) Mr. Lucas told the Board the CPC may fund the project to restore the sidewalks around the library. Mr. Lucas feels hopeful that the CPC will approve funding for the sidewalks and that lighting can be added at the Library at that time.

Ms. Oliveira made a motion to support the lighting installation of the Historic Street lamps around Town Hall. Mr. Lavalette seconded. Vote was unanimous.

Mr. Oliveira told the Commission he has met with the budget team regarding the FY22 budget and has requested additional funding for the antique fire apparatus.

Correspondence

Members of the Manjiro Society met with the Commission to provide an update on the carriage house renovations. They have paid for the renovations with CPC funds and donations. The commission discussed the endorsement of town historic buildings that are not on the national historic register before any renovations or changes are made to these buildings.

Mr. Lucas suggested applying for a CPC grant to record all the historic buildings.

Mr. Lavalette made a motion for the historical commission to deem the Manjiro Society property as historically significant and to endorse the carriage house project. Mr. Silvia seconded. Vote was unanimous.
