**Demo Delay- 27 Fort Street**

Selectman Silvia made a motion to re-open the public hearing for 27 Fort Street. Mr. Lavalette seconded. Vote was unanimous.

Chairman Oliveira said Town Counsel has provided some guidance on the demo delay bylaw. Town Counsel has stated, per the bylaw, that if the Commission decides to allow demolition then the role of the Commission is finished. Mr. Oliveira reached out to the architect and expressed the concerns of the commission regarding the design of the new building and trying to keep it in line with the neighborhood's style. The owner of the property, Mr. Leung, stated he and his family want to stay in the neighborhood and keep the new house with the same styles as the other homes. Members offered their thoughts on the demolition of the home and felt there is no longer any historical value left to the home.

At 6:43 pm Mr. Lavalette made a motion to close the public hearing. Mr. Medeiros seconded. Vote was unanimous.

**Financial Report**

Chairman Oliveira reviewed the financial report with the commission. Chairman Oliveira met recently with the Town Budget team to discuss the FY23 budget and has requested a slight increase in funds to cover expenses for the next fiscal year.

**Chairman's Report**

Chairman Oliveira has spoken to Rex Monument who can install the bridge plaque at the entrance of the New Bedford/Fairhaven Bridge. The cost is between \$1200 - \$1500. Mr. Oliveira will put in a request with the Select Board to use the funds from the route 6 median gift account.

**Committee Liaison Reports**

Mr. Lavalette said the Community Preservation Committee (CPC) had concerns regarding the sign over the Fire Museum. Mr. Lavalette has contacted Signature Signs who can rebuild the wooden sign and not use vinyl lettering but cut the letters into the wood. Mr. Lavalette has also painted the hinges on the shutters black. Mr. Lavalette said CPC has approved the project.

**Correspondence**

Mr. Oliveira reached out to the Whaling Museum regarding the Nimrod Cannon. The Whaling Museum wants to retain ownership of the cannon and does not want to permanently give the cannon to the Town. The Whaling Museum has concerns the cannon is not properly being maintained at this time, but correspondence to Mr. Dawicki has been unsuccessful. Mr. Oliveira is in contact with town counsel for some guidance.

**Commission Bills**

Commission members signed this month's bills.

**Academy**

Mr. Oliveira said he is still working with the architect and contractor to finalize the punch list. Town Counsel has met with the Architect to try to resolve this issue.

**Fire Museum**

Mr. Oliveira reported that the Tree Warden has trimmed the tree that was overhanging the roof at the Washington Street firehouse.

**Fort Phoenix**

Ms. Mello expressed her concern that the secondary gate near the bathhouses on the State side of the Fort has been removed and the first gate is still not getting locked at night. Mr. Oliveira will try again to contact the State for more information. Ms. Mello will reach out to the Fairhaven Police Department to find out why they are not locking the gates at night.
