### A. Eric Britto, 50 Manhattan Avenue – Driveway Waiver

Mr. Furtado - Mr. Britto is here tonight for a driveway waiver for his property at 50 Manhattan Avenue.

Mr. Britto- I thought that I went to the office and asked them to put cobblestones on the previous permit. When I got the letter stating that I needed to get a waiver I stopped immediately and went to the office to straighten this out. I understand that I have to pay a fine. I just want to redo the existing driveway with cobblestones and do everything correctly.

Mr. Wotton - What is the total width of the opening on the Bay street side?

Mr. Britto – I am not sure as this driveway was done 11 years ago.

Mr. Wotton - It looks like with both driveways you would need 40 feet. In addition, you would need to sign a waiver stating that the Town would not be responsible for the cobblestones if they were to be damaged.

Mr. Durant motioned to approve a driveway waiver for a forty-foot wide opening at 50 Manhattan Avenue on the Bay Street Side. Ms. Smith seconded. Vote unanimous.

# B. Joshua Ferreira, 138 Spring Street – Driveway Waiver

Mr. Ferreira – My property is on the corner of Spring Street and Rochambeau Street. Currently the existing driveway is on the Spring Street side and is 20 feet wide. I would like to make the existing driveway an L shaped driveway with a 20 foot opening on Rochambeau Street.

Mr. Wotton - Are there any utilities in the way?

Mr. Ferreira - The sewer is located near the fire hydrant but we will be far enough away from that.

Mr. Hobson motioned to approve the driveway waiver for 138 Spring Street for a second opening 20 feet wide on the Rochambeau Street side. Ms. Smith seconded. Vote unanimous.
