

# A. GCG Associates, Sign Agreement for Professional Services – Jerusalem Road Stormwater Improvement \$26,350.00

Mr. Furtado - Earlier this year we were fortunate to receive a grant in the amount of \$275,000 to make improvements to the stormwater system on Jerusalem Road. With these improvements, we are hoping to be able to open up shell fishing in that area. With this grant, the Town is responsible for \$25,000 and we will be using Chapter 90 funds.

Ms. Smith motioned to Sign the Contract Agreement with GCG Associates in the amount of 26,350.00 for Jerusalem Road Stormwater Improvements. Mr. Rapoza seconded. Vote unanimous.

# B. Tighe & Bond, Upgrade to WWTF Payment #2 \$48,000.00

Mr. Furtado - Payment #2 was missed because it was sent to the wrong email and no one received it.

Ms. Smith motioned to approve Payment #2 to Tighe and Bond in the amount of \$48,000.00 for the Upgrades to the Wastewater Treatment Facility. Mr. Rapoza seconded. Vote unanimous.

### C. Tighe & Bond, Upgrade to WWTF Payment #4 \$125,000.00

Mr. Hobson motioned to approve Payment #4 to Tighe and Bond in the amount of \$125,000.00 for the Upgrades to the Wastewater Treatment Facility. Ms. Smith seconded. Vote unanimous.

# D. Articles for Special Town Meeting

Mr. Furtado – We have three articles for Town Meeting in November. The first article is for Safe Routes to School, currently we are waiting for the verbiage from the State's Legal Counsel in order to take easements. The second article is to request additional funds for the Water Department because we have an employee retiring in December and this will be for his payoff. The third article is to request \$60,000 to be added to the Sewer Budget to replace a valve at the South Street Pump Station.

Ms. Smith motioned to approve the three Articles for the Special Town Meeting. Mr. Rapoza seconded. Vote unanimous.

E. Notice of Decision & Intent to make a Betterment Assessment for the Cost of Laying Sewer Line on Sunset Beach Road, Leeward Way, Windward Way & Melpen Way

Mr. Furtado - This document is a legal document that I am asking the Board to sign. This is part of the \$1,000,000 article for the Sunset Beach Road Sewer Extension. There will be a contractor hired to install a 2 inch low force main on the previous mentioned streets. The Board is required to notify the residents mentioned in the letter that there will be a betterment assessed for the installation of a sewer line that will be their responsibility and that will be lien to their property.

Mr. Wotton - Will they be paving Mel Pen Way?

Mr. Furtado - Yes, the Town will have to accept the road and then we can pave it.

Ms. Smith - Is everyone that will be affected aware of the Notice of Decision & Intent.

Mr. Wotton - There have been numerous meetings.

Mr. Rapoza motioned to Sign the Decision & Intent to make a Betterment Assessment for the Cost of Laying Sewer Line on Sunset Beach Road, Leeward Way, Windward Way & Melpen Way. Mr. Hobson seconded. Vote unanimous.

Mr. Furtado – When we looked into resurfacing the bike path a few years ago it was going to cost around \$270,000 to repave the whole thing and we were going to start with the Mattapoisett section between Gellette Road and Shaw Road because that was the worst section.

Mr. Wotton-I would also like to send a letter to the Select Board letting them know that the bike path falls under the purview of the BPW and if they want to discuss the bike path then we should have a joint meeting. At Livesey Park there are three burning bushes that I believe are dangerous. I see kids hiding in them and then parents looking for them franticly. I would like to see the bushes removed.
