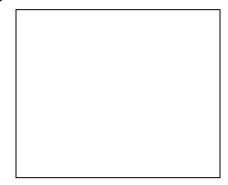

Mr. Wotton – We hired Mr. Girouard at the last meeting.

C. Cooke Park Sign Replacement

Mr. Wotton – We are going to skip over this until after the next Historical Committee meeting. They are not scheduled to meet until next month, and they are going to discuss this on their next agenda. We are going to give them the allotted time that they need to discuss it at their next meeting to get the sign moved, and if they can't get the signed company to move it, then the BPW is going to move it. It is only fair to give them the opportunity to correct the wrong that was done. We did look back at their minutes, and it states that the sign should be approximately 8 feet from the curb, I would say 8 feet could give or take a couple of feet but double that is a little bit much. Also, if the sign company needs help digging the holes in the right spot we can assist them.

We would like to make a new parking lot in front of the building.

Mr. Wotton – How many parking spots are you looking to have.

Mr. Crabb – I am looking to double what we currently have, maybe 30 spots. I can put a sketch together and present it to the Board. We are just concerned about the safety and our staff.

Mr. Crabb will put a few sketches together and present them to the Board at a later date.

VII. Public Comments / Open Forum

Ms. Simmons – My life stems from my address where I live. The Water Department shut off my family's water today.

Mr. Wotton – Yes, and we have been advised from Town Counsel not to address that at our meeting.

Ms. Simmons – I would like to just state that we had submitted requests in writing on your recommendation at the last meeting that we were taken out from, that you wouldn't allow us to speak. We submitted requests to be on a meeting agenda to discuss the project before it was slated to happen, and those requests were ignored, and then the Board went on to talk about our address at meetings off agenda and make decisions about us without us being there and without us being invited.

Mr. Wotton – Decisions were not made Miss Simmons, regarding your address or anything without being here live on TV or in executive session. I'm going to stop your comments as of right now I've allowed you to speak. I'm going to read the letter from our Town's Attorney which you were handed.

Ms. Simmons – Was that letter approved by the Board?

Mr. Wotton - This letter has been approved by the Town Attorney.

Ms. Simmons – But was it approved by the Board?

Mr. Wotton – It was approved by the Board, the Select Board, and everybody else who has the authority to hire and enter into contract with the Town's Attorney.

Ms. Simmons – Was it approved by the Board?

Mr. Wotton – Ms. Simmons, this is coming from the Town's Attorney, Heather White.

Ms. Simmons – I just want to know if it was approved by the Board because Ms. Morton Smith asked about it and said, what is going on with item 3, and Mr. Furtado said, a letter was written, and police are involved, and if they don't comply there will be penalties, and you said, move on.

So that letter was not approved by the BPW Board and does not hold the authority from the Board.

Mr. Wotton -The letter holds the authority from the Town Attorney who represents the Board of Public and the Select Board, as well as the Town of Fairhaven, and they are the Town Council, and they represent everything that I do here, and her letter that was given to you on April first.

Mr. Wotton read the letter from Town Council (Attachment A).

Mr. Wotton - That is the only comment that I am going to allow any further comments I am going to bang my gavel and have the police officer remove you from the meeting. We are going to move on and continue on with our agenda.

Ms. Simmons - I just have a question about how long we can expect our children are going to be living without water.

Mr. Wotton – That is a great question. And because this board has great consideration for your family, unlike what you've been doing, putting your children on the sidewalk in the right way.

Ms. Simmons – You spoke at us very harshly last time, enough to terrify my children.

Mr. Wotton – Enough that I had to call the police department to remove you from my meeting.

Ms. Simmons – You threatened to have me arrested in front of my children.

Mr. Wotton - Correct, because you keep putting your children as pawns in front of you. You want to be on open session I am going to put it out there.

Ms. Simmons - What are you saying?

Mr. Wotton – You are putting your children out there at the street, and making the police remove them. That is what happened again today. I am moving on the discussion over regarding 97 Farm Field Street. Any further discussion will be with Town Council.

Ms. Simmons – Will that cost us money?

Mr. Wotton - This is costing the Town money.

Ms. Simmons – That is your choice to do that, not mine.

Officer Dillon - Ma'am. They are moving on. I do not want to have to remove you from the meeting.
