They are going to have separate sections for individuals who cannot walk very far and will have a separate mic along with a floating mic. They are also in the process of obtaining amplifiers. They will also have available seating for individuals in wheel chairs. Eleanor said they are working on having an interpreter. Pamela brought up setting up time at a Select Board meeting to discuss what we learned at our Massachusetts Office of Disability training regarding accessible meetings.
