#### Commission Bills:

• Motion to approve payment of invoices to Eversource and Chadwick's Awards for a total of \$1,280.64 [see attached listing of bills] (N. Mello, B. Luey). Motion passed unanimously.

## Chair Report:

• Update on CPC application for the Academy Building to re-side three exterior walls, make the back door and bathroom ADA compliant. Chair Kelly appeared before the CPC on November 20<sup>th</sup> to answer members questions.

## Properties update:

- Academy Building: N/A
- Fire Museums:
  - Washington Street N/A
  - Spring Street N/A
- Fort Phoenix: The flag was replaced this morning due to wind damage and the wheels have been removed from the field guns for winter storage.
- Old Stone Schoolhouse: The site is closed for the season. Almost 400 visitors came to the Schoolhouse this season, up 75% from last. Chair Kelly will be featured in an episode of The Magazine to air on <a href="https://www.fairhaventv.com/">https://www.fairhaventv.com/</a> (Channel 95). Ideas were floated for possible cider press experience at this site next fall, A. Botelho to check with Board of Health to see if possible.

## Discussion/Action Items:

- Notice of planned updates and repairs to Town Hall. <u>Motion</u> to approve minisplit installation in the East Room with a recommendation to locate the condenser so as not to be visible from the street AND to repair the weathervane and the roof. (N. Mello, B. Luey). Motion passed unanimously.
- Community Development topics (A. Botelho)
  - A process is being developed for approval of street art on town owned properties with input from the FHC, the Select Board and the Cultural Council. This is for "temporary" exhibitions/installations. She will check with New Bedford folks to learn how they developed their process.
  - Old Tyme Holiday event is scheduled for Saturday December 12 from 10:00am to 3:00pm. There will be many more outdoor activities this year. Looking for ideas for next year. Perhaps have Santa end his firetruck ride at one of the old firehouses?
- Revisit and review November 6 vote to move recurring meeting day from 1<sup>st</sup> Wednesday to 1<sup>st</sup> Tuesday of each month. Correspondence was read into the record [see attached correspondence] at W. Oliviera's request. Lengthy discussion ensued. Motion to discuss this at our next meeting on Wednesday January 8<sup>th</sup> and make a decision then. (B. Luey, N. Mello). Motion passed unanimously.

• Community Preservation Committee – Next meeting January 22, 2025 when deliberations will begin on this year's round of funding awards.

Personally, I can not make the first Tuesday as I already have a monthly commitment on that day.



You do what you feel you need to do, Wayne. You state "to change a meeting date to accommodate one person's attendance is wrong for the rest of the membership," but you are asking the rest of the membership to keep a date just to accommodate your attendance. And you are one member. So explain to me how it is different?

Per the agenda, we are obviously willing to take the matter up again, given that you have raised the issue as problematic. This is in keeping with all customs and protocols of civil behavior and legal functioning. But even that clearly isn't enough for you, even though you specifically asked for precisely that action. You simply wish to create a problem where there isn't one, and cast yourself as a victim when you aren't one.

My impression lately is that nothing the commission can do will be good enough for you, unless we go back to the way things were when you ran it. That is clearly not the will of the commission, since nothing has been done without a majority vote. And remember, your vote is worth neither more nor less than anyone else's on the commission, including whomever is presently serving as chair.

It would be better for everyone, you most of all, if you would decide if you wish to be a productive member of the commission, or if your goal is simply to disagree with every action of the commission going forward. Both are within your legal rights, to be sure, though I feel you would find your role more rewarding if you were to choose the former.

If you wish to waste the AG's time with something like this, that is entirely your decision. My guess is they will ask if you took any action to get the dates changed back first, or had any proof that the change was directed at you personally, before taking the step of complaining to them. I doubt they will be amused when they learn that you have done neither, nor even given the Commission time to respond to your initial complaint. Facts matter.


Or, you could behave like an adult, wait to see what the commission decides on Tuesday, and plan your course of action from there.

I am sorry the Historical Commission is no longer run the way you want it to be, Wayne, but that has less to do with me and the Commission itself than it does with your own behavior. Indeed, my expectation was that the Commission likely would have voted to reverse the date change at our meeting next week (it was going to be my recommendation, in fact,) though your current use of threats and insults to the members may actually change that outcome.

Perhaps instead of pointing fingers, you could consider how you can best contribute to the commission you supposedly support.

Since I can not attend this weeks Commission meeting I would like to request that this e-mail from me be read aloud during the appropriate agenda item of:

"Request to revisit scheduling of monthly meetings"

Dear fellow members

I have asked that reconsideration of our monthly meeting day be placed on the agenda for this month. I had further asked that the meeting day remain on the customary "first Wednesday of the month" so that I could attend and state my case in person. Since I am unable to attend meetings on the first or second Tuesday of the month I have asked that this statement be read into the minutes on my behalf.

With the change of our staff liaison, the Commission voted last month to change the monthly meeting date to the first Tuesday of the month from the long-time posted day of the first Wednesday of the month that goes back some 20 plus years if not longer. When a member decides to join the Commission the date of the meeting is already set, and members make that decision to join based on whether they can make that particular meeting date.

Now, without warning, the regular meeting date is changed leaving a member to have to decide if they can continue to serve because the day of the month they signed up for has now been altered. Not everyone's schedule is that flexible depending on one's activity in other clubs or organizations that they can just switch dates around.

The second point is that the date was altered to accommodate a "non-voting "staff liaison who has stated to me that she can easily watch the recording of the meeting and give attention to any matters that need her attention. She further stated to me that she would make this simple resolution known to the Chair.

In summary, by changing the meeting day, you have accommodated a non-voting member but have excluded a "voting" member" of the Commission . The decision to change any meeting day permanently should have come to the full membership and not decided on by the 5 members in attendance at one particular meeting where 2 members were absent.

To be clear this has nothing personal to do with the staff liaison as I am happy to have them help trouble shoot any issues that come up, but the Commission members participation should be the main concern of any date changes.

Thank you for your consideration of this matter and I hope you will agree to return to our regular schedule of the first Wednesday of the month.

Hi Wayne, happy to do that. Indeed, I already plan to read all of your correspondence on the matter into the record, since I feel it is pertinent.

Please note this pertinent fact as well: moving the meeting to December 3 this month was voted upon by a majority of the Commission. We therefore could not simply move it back to Wednesday without taking another vote, which is happening tomorrow per the agenda. Had I arbitrarily moved the meeting back to Wednesday based solely upon your email, I would have potentially been in violation of open meeting laws and would certainly have been acting in direct opposition to the vote of the commission. As a reminder, the chair holds no power whatsoever outside of a majority vote of the commission, and is prohibited from acting unilaterally. You should know this as well as anyone.
