

Mr. Ferro - I am the chairperson on the Commission of Disability and I was in the office last week inquiring about how to get a beach mat that would extend from the parking lot to the beach. This would help people with disabilities get down to the beach.

Mr. Furtado - I put \$25,000 in the Park Department's Capital Plan for these items.

Mr. Hobson – In front of 12 Nakata Avenue, Wilbur's Point, Mary Street and Bayberry Street could all use some fill. Union Wharf has some brush that needs to be cleaned up near the dumpster and the raft that is next to the dumpster needs to be moved as well.

Mr. Wotton – There is still debris on the bike path that needs to be cleaned up from the storm.
