OLD BUSINESS

The replacement of the HVAC system is underway. Three mini splits have been installed in the activities rooms and one in the congregate meal/activity room. The control panel for the mini splits is located in the reception area where only staff has access. Presently the outside unit is being installed. Once that is complete, the unit in the utility closet will be removed and replaced. Some activities were cancelled. The Social Day Program was able to remain at the senior center as well as MOW. The Araujo Brothers HVAC Company has been remarkable to work with.

The COA director met with the selectmen on 3/2 to review the FY21 budget. There is only 2 changes to the budget. One is a request of an increase of \$500.00 to vehicle repair line as the 2008, and both 2012 vans are requiring work. The other is a decrease in the wage line of approximately \$2,000.00 related to the difference in wage of the previous custodian and the new custodian and the fact that there is no by back.
