- 3. Three new tires have been purchased for \$317.00 taken from the COA gift account. When the grant for \$302.00 is received form MArtap, the check will be deposited back into the gift account.

### **NEW BUSINESS:**

- 1. The Article for Social Day was approved at the Town Meeting to spend up to \$175,000 in FY21 for the purpose of operating a Supportive Social Day Program.
- 2. The COA Emergency Preparedness Plan has been updated and submitted to Deputy Chief Todd Correia as requested. A copy of the opening plan of the COA was included in the plan.

- 1. The water filling station has been received. The Rec Center is waiting on the delivery of theirs. Once theirs is received, the plumber who installed the original water coolers will install the water filling stations on both sides after approval of quote for work to be done. The town electrician will do the electrical work needed.
- 2. The Article at the Town meeting for Social day to spend up to \$175,000.00 in FY21 passed.
- 3. Three new tires have been purchased from Roland's Tire for \$317.00 and paid for through the COA Gift Account. When the MArtap grant for \$302 is received, it will be deposited into the COA Gift Account.
- 4. Chair yoga, Osteo and Health awareness classes continue to meet outside on the grounds of the COA near the Bocce Court under the trees. Covid precautions are in place and the classes seem to be going well. Participants are abiding by the 6' distancing, wearing masks and temperatures are being taken upon arrival.
- 5. To answer a board members question from the last meeting as to how the furloughed staff are paying for their health benefits, only one Social Day staff has health benefits from the town and she writes a check to the Town monthly to cover her portion of the expense.
- 6. Van #2 and Van#5 have received stickers. Van #3 will go to SRTA for the sticker (awaiting call back from SRTA for the date) and Van #4 needs a new tire before it can go for a sticker. It is off the road at present until the garage can install the new tire.
- 7. The updates for the Emergency Preparedness Plan for the COA has been submitted to Deputy Chief Todd Correia. The COA re-opening plan was also sent as requested.
- 8. Seventy five Farmers Market coupon booklets for \$25.00 each were received from Coastline and distributed to those who signed up to receive them. These coupons are for Fairhaven residents 60 years old and older only.
