

# <u>Fairhaven Council on Aging • Board Meeting Minutes</u> <u>August 13, 2024</u>

- 1) The meeting was legally posted on August 8, 204
- 2) The meeting was called to order by Martha Reed at 9:06am
- 3) Meeting Minutes:
  - a. Joyce Veilleux made a motion to accept the minutes from the May 14,2024 Meeting, Michael Hevey seconded, vote passes.
- 4) Financial Report:

Nothing out of the ordinary has been spent during the first month of the new FY25 fiscal year.

# 5) Old Business:

- a. EOEA Supportive Social Day Expansion Grant: Social Day has now opened to 5 days. Census is currently low on Mondays and Fridays for now until all case managers know about the program being opened 5 days a week. Voc-Tech will be doing a co-op in September.
- b. **Veterans room renovations:** Every photo that was on the wall is now framed and back to the center. The moving wall that was approved at town meeting will be installed in the third week of August. The walls will also be painted.
- c. **Hiring a part-time Outreach Worker:** Job description and opening will be up by the end of the week. This position is funded by ARAW as well as the Formula Grant.

### 8) New Business

- a. Intergenerational Field Day: During this event, we had a total of 70 children and 35 adults. Due to the rain, all games were moved inside. They played intergenerational bingo, along with various other games and enjoyed Mac's Soda Bar for the cookout. Blazing Saddles Petting Zoo was a hit! They all ended their day with ice cream from Dorothy Cox.
- b. Fall Programs: Starting to put together holiday programming. We will be hosting Thanksgiving Dinner again. Annual Veterans Day luncheon, is upcoming as well and we are hoping to have AllTrust Bank to sponsor once again. During the luncheon, the wall will be rededicated.

<u>Transportation Utilization:</u> In July 161 Rides were provide to 55 Seniors.

<u>Volunteers</u>: 24 volunteers provided over 500 hours of service at the COA in June. The dollar value of these hours is over \$11,500.

<u>Community Needs:</u> 5 Seniors were assisted with SNAP applications; 4 seniors were assisted with senior housing applications. 2 new households were registered with CSFP Food Bank services. 1 Fairhaven resident was assisted with funds from the Keeping Seniors Warm Program and 1 Fairhaven resident was assisted with a phone and medical supplies out of the Emergency Fund for \$163.

<u>In-person event highlights:</u> The Single Senior Supper Club had 30 persons in attendance. The LGBTQ+ Supper Club Supper Club was attended by 28 persons attend last month. Over 60 persons participated in the congregate lunch program (382 served meals).

<u>Social Day</u>: Please see the attached reports from Sally Bourke. The program will go back to 5 days per week starting Monday August 5, 2024.

<u>Hybrid Programming</u>: We've been able to live stream several events, including Moving with Moxie, the monthly Memory Café, and Healing with Grace. We are in the process of planning nutritional programming with Community Nurse, Coastline, and the Marion Institute to further expand our programming this fall.

<u>FY25 Improvements:</u> The dividing wall will be completed the end of August. Painting and redecorating is slated for September.

<u>Summer Programming Update:</u> Our second Intergenerational Field Day was held on Tuesday August 6<sup>th</sup> from 10-2. Over 70 children and 45 adults participated. The attendance was lower than planned due to weather, but the overall feedback was extremely positive.

<u>Fall Activities Update:</u> We have just begun putting together the Fall and Winter schedules.
