1. Meeting called to order 6:31pm by Michael Kelly, Chair.

2. Minutes: Motion to approve minutes from February 4 and 12, 2025 with the date corrected on the 2/12/25 minutes (B Luey, N Bekemeier). Motion passed unanimously.

- 3. Financial Report: See attached 2025 Budget Balance Sheet as of March 4, 2025.
 - <u>Motion</u> to approve payment of invoices to Eversource and Brewer Banners for a total of \$626.99 [see attached listing of bills] (N Mello, B Luey). Motion passed unanimously.

4. Chair Report:

- Historical Commission vacancy any interested members of the community are invited to apply through the Select Board.
- *Update of Fort Phoenix Flagpole:* Motion to approve the quote provided by Bete Fleming to replace the existing flagpole with 30' Venus Apollo Series Severe weather fiberglass flagpole in the amount of \$3,339.00 (N Mello, B Luey). Motion passed unanimously.
- Grant Opportunities: There are two possible opportunities to secure grant funding. The first is related to documented historical battlefields, The Battlefield Restoration Grant administered under the National Parks Service, which requires no matching funds, and the amounts awarded go from \$20,000 to \$200,000. There are many areas in the Fort that need repair: Door to bunker, cannon caissons, the wall, and lighting for the flag. The second grant opportunity was deemed to be unattainable given that the deadline has passed.
- Eagle Scout Project: Motion to approve Chair Kelly's signing of the required documentation for James Edminster, candidate for Eagle Scout (N Bekemeier, N Mello). Motion passed unanimously.

3. Properties update:

A. Academy Building:

- a. In an effort to increase traffic to the Museum during the summer months, the Fairhaven Historical Society will be hosting lectures and talks on Saturday mornings. <u>Motion</u> to approve the Society using the first-floor classroom as a venue to deliver lectures and talks (N Mello, N Bekemeier). Motion passed unanimously.
- b. Issue of the Society not having a key to access the Academy Building. There is no process in place for key distribution at the moment. <u>Motion</u> to issue a key to Rick Martin, as a member of the Commission, for the Academy Building (N Mello, N Bekemeier). Motion passed unanimously.

B. Fire Museums:


- a. Washington Street N/A
