- 2. Asking about 4-year term for Planning Board,
- 3. Town meeting representatives: ? any way to look at the quorum structure. As stands unable to ever meet quorum at precinct meetings prior to Town meetings, possibly do a percentage. Possibly Town moderator will know more about the structure.

1. Does the Charter need a majority or 2/3rd vote to pass?

Despira Longinidis Precinct 4

- 1. Want to know if there are checks and balances. Feels there is a problem between departments.
- 2. Questions same people being on multiple boards. Feels there should something to dictate how many boards someone can be on

Doug Brady Precinct 4

1. Section I: wants words prior approval added

- 2. Section K : consider adding reorganizing any structure /infa structure. Feels selectboard should be involved in the decisions
- 3. Section N : Selectboard suggest adding Question who is appointing authority. Suggests Selectboard should review elected verses TA who is appointed.
- 4. Signing of contracts: feels TA should not be allowed to bind Town into 3 year or longer contracts. Also, there should be dollar amount Possibly higher than \$150,000 over length of contract. For example, recent dispatcher contract for 5 years.
- 5. Question on contracts that state Selectboard or Town meeting can not lower money.? Wording of contracts based on appropriation of Town meeting to lower/raise
 - Feels it binds Town hands.
- 6. Paperwork for Committee member: wants wording to say should provide 48 hours
