MCC has updated its website and is promoting all of its grant and funding opportunities

- -LCC program
- -Tribal Cultural Council Program- led by tribally appointed volunteers who administer an annual grant program to support local cultural projects.
- Grants for Creative Individuals- practice grants for a wide range of creatives
- Cultural facilities Fund- Grants to support the acquisition, design, repair, rehabilitation, renovation, expansion or construction of nonprofit cultural facilities.

Nonprofit cultural organizations, municipalities and colleges or universities that own or lease cultural facilities are eligible to apply.

- -YouthReach- Grants to Creative Youth Development programs that integrate substantive and ongoing arts, humanities and science opportunities into a collaborative community response.
- Creative Experiences- Grants to organizations (including schools) to fund festivals, projects, residencies and other cultural activities in the arts, humanities and sciences.

due October 9. FCC will receive \$11,900 from Mass Cultural Council and \$1250 from the town making \$13,150 total funds for 2026.
