### Requests for Determination of Applicability

a. CON 023-536: Ebony Street, Map 43A, Lot 322

Request for Determination of Applicability filed by Relentless Real Estate Group for the construction of a single-family home and associated work. The septic system will be installed outside of the 100' buffer zone of the Bordering Vegetated Wetlands (BVW). All filling & grading will be done at a distance greater than 70' from the existing BVW.

b. CON 023-537: 18 Point Street, Map 28B, Lot 207

Request for Determination of Applicability filed by Antonio & Doreen Albuquerque to remove existing crushed shell driveway, regrade to sub-grade elevation and install permeable pavers on a drainable base.

- c. CON 023-490, SE 023-1496: 0 Perry Street, Map 31A, Lot 434 (Earle Street) Continued from April 7, 2025, April 28, 2025, May 19, 2025, August 25, 2025 & October 6, 2025
  Notice of Intent filed by David Vermette to construct a single-family home with associated driveway, grading, and utilities. The applicant also proposes to stabilize a portion of the lot previously disturbed and cleared. The parcel contains NHESP Priority Habitat and Buffer Zone to Bordering Vegetate Wetlands at Assessor's Map 31A, Lot 434.
- d. CON 023-526, SE 023-1511: 110 Middle Street (Seaport Inn), Map 12, Lot 17 Continued from August 25, 2025

Notice of Intent filed by Uday Patel to install floating docks and piles (~40 – 12-inch wooden piles to be installed to support 302 linear feet of six-foot-wide floats and 600 linear feet of 4-foot-wide finger floats). Work to take place within Land Under the Ocean & Land Subject to Coastal Storm Flowage, FEMA Flood Zone AE (El.6').

e. CON 023-538, SE 023-1515: 22 Point Street, Map 28B, Lots 204, 205 & 218

Notice of Intent filed by John & Gia Zolotas to remove the existing concrete seawall and patio and reconstruct with seawall, perimeter pervious patio, firepit and flagstone walkway. The entire site falls within Land Subject to Coastal Storm Flowage, Flood Zone VE (El.16') with work to take place within the buffer zone to Coastal Bank and Coastal Beach.
