Present: Charles Murphy Sr., Andrew Romano, Natalie A. Mello, Keith Silvia, Andrew B. Saunders and Anne Carreiro. **Not Present**: Keith R. Hickey

Planning Board Present: Jessica Fidalgo, Sharon Simmons, Ruy daSilva, Miles Grant, Sean Powers, Kevin Grant and Patrick Carr

Mr. Murphy opened the Select Board meeting at 6:32pm

Ms. Fidalgo opened the Planning Board meeting at 6:35pm and confirmed a quorum was present.

A moment of silence was observed in honor of Veterans' Day.

Mr. Murphy reviewed the process for the joint meeting, interview and appointment. He advised both Boards that Ms. Costen had rescinded her application (*Attachment A*).

PLANNING BOARD APPOINTMENT INTERVIEWS (Joint with the Fairhaven Planning Board)

Interview Candidates for one Planning Board Vacancy and Consider appointment.

Candidates: Rick Trapilo, Jeffrey Lucas and Diane Tomassetti

Each candidate addressed both Boards and gave an opening statement.

Mr. Murphy and Ms. Fidalgo asked each candidate the same questions in rotation. At the end of the interview, all candidates were thanked for stepping forward and Mr. Murphy opened discussion to the Select Board and Planning Board.

Patrick Carr addressed both Boards regarding the conflict of interest (COI) disclosure from Andrew Romano and copies of the North Fairhaven Improvement Association (NFIA) attendance from 2022 to present (*Attachment B*). Mr. Carr asked Mr. Romano to recuse himself due to being the NFIA President and the perceived conflict due to Mr. Lucas being a member of the NFIA. Mr. Carr reviewed other examples of conflict of interest disclosures submitted to the Select Board dating back to April, 2025 and referred to Mr. Romano's votes on these matters.

Mr. Romano addressed both Boards about his COI disclosure, the NFIA attendance records that were distributed to both Boards and the summary of his conversation with the State's Attorney of the Day (AOTD) Christopher Popov (Attachment B). Mr. Romano said in past meetings he recused himself when a financial relationship existed and he would not be recusing himself tonight.

Mr. Carr asked if Mr. Romano received the opinion in writing. Mr. Romano said he did not. Mr. Murphy added that calls to the AOTD are recorded/documented for reference.

Mr. Lucas asked for clarification on the accusations against him and said that he had not been to an NFIA meeting in over a year due to scheduling conflicts but participates in community events when he can.

Motion: Mr. Silvia motioned to appoint Diane Tomassetti to the Planning Board for a term through Town Elections in June, 2026. Mr. Saunders seconded. Roll Call Vote: Mr. Saunders, Mr. Murphy, Mr. Silvia, Ms. Simmons, Mr. Carr and Mr. daSilva in favor and Ms. Mello, Mr. Romano, Ms. Fidalgo, Mr. K. Grant, Mr. M. Grant and Mr. Powers opposed. The motion failed (6-6-0).

Motion: Ms. Mello motioned to appoint Jeffrey Lucas to the Planning Board for a term through Town Elections in June, 2026. Mr. Romano seconded. Roll Call Vote: Mr. Saunders, Mr. Silvia, Ms. Simmons, Mr. Carr and Mr. daSilva opposed and Ms. Mello, Mr. Murphy, Mr. Romano, Ms. Fidalgo, Mr. K. Grant, Mr. M. Grant and Mr. Powers in favor. The motion passed (7-5-0).

Motion: Mr. K. Grant motioned to adjourn the Planning Board meeting at 7:19pm. Ms. Simmons seconded. The motion passed unanimously (6-0-0).

Use of Town Hall Auditorium: Off Broadway, December 18, 19 and 20, 2025

Mr. Murphy read from the application and details of the event.

Motion: Mr. Saunders motioned to approve the application from Off Broadway School of Dance for a dance recital on the dates of December 18, 2025 from 3-8p, December 19, 2025 from 4-8p and December 20, 2025 from 4-8p. Ms. Mello seconded. The motion passed unanimously (5-0-0).

Appointment Request: Public Safety Complex Committee: Timothy Cox

Mr. Murphy read the request.

Motion: Mr. Saunders motioned to appoint Timothy Cox to the Public Safety Complex Committee. Ms. Mello seconded. The motion passed unanimously (5-0-0).

Special One-Day All Alcohol License: Hanami Café, November 29, 2025 8p-12a

Mr. Murphy read the application.

Motion: Mr. Saunders motioned to approve the Special One-Day All Alcohol License for a promotional event at the Hanami Café on November 29, 2025 from 8pm-12am contingent upon payment of the fee at least seven days prior to the event. Ms. Mello seconded. The motion passed unanimously (5-0-0).

Special One-Day All Alcohol License: Discover Fairhaven: Olde-Tyme Holiday, December 13, 25 10a-5p Mr. Murphy read the application.

Motion: Mr. Saunders motioned to approve the Special One-Day All Alcohol License for Discover Fairhaven's Olde-Tyme Holiday Event on December 13, 2025. Ms. Mello seconded. The motion passed unanimously (5-0-0).

Request the Use of Rogers School Parking Lot: Discover Fairhaven: Olde-Tyme Holiday, December 13, 2025 Mr. Murphy read the request.

Motion: Mr. Saunders motioned to approve the use of the parking lot at the Rogers School during the Olde-Tyme Holiday event on December 13, 2025 for vendor and attendee parking. Ms. Mello seconded. The motion passed unanimously (5-0-0).

PUBLIC COMMENT

None received.

ACTION/DISCUSSION

Consider Reclassification of Treasurer/Collector Position to Grade 20 on the Town's Wage and Classification Schedule

Mr. Murphy read the request.

Motion: Mr. Saunders motioned to approve the Reclassification of Treasurer/Collector Position to Grade 20 on the Town's Wage and Classification Schedule. Ms. Mello seconded. The motion passed unanimously (5-0-0).

Update on Zoning Bylaw Update Project

Mr. Murphy reviewed the item. Mr. Silvia asked about a Request for Proposals (RFP) that he said he thought was part of the process.

Ms. Carreiro said she would follow up with Mr. Hickey. The Board tabled further discussion.

Consider Amending the Flag/Banner Policy

Mr. Murphy read the recommendation to change the deadline from sixty days to thirty days.

Motion: Mr. Saunders motioned to approve the amended Flag/Banner Policy as presented. Ms. Mello seconded. The motion passed unanimously (5-0-0).

Consider Amending the Use of Town Hall Process and Application

Mr. Romano reviewed the proposed updates to the language in the policy including changing it from Town Hall Auditorium to Town Hall Facilities. Mr. Romano added that some requests are for the use of bathrooms or electricity and changing to "facilities" accommodates requests for the use of any part of Town Hall. He advised the Board that another update was to the non-profit rate for Fairhaven Town Affiliated Groups that are listed on the application; this change would remove the rental fee only and all other fees would apply based on the event request.

Updates to the application forms will be done based on the Board's vote and communication to applicants will be sent to advise of the changes and what fees apply (ex. Custodian, Audio/Visual, Off-Duty Police, Board of Health).

Discussion ensued as what a "Fairhaven Affiliated Group" is and is not. Fairhaven businesses and non-profits would not be considered under this category.

Motion: Mr. Saunders motioned to approve the amended Use of Town Hall Process and Application as presented. Ms. Mello seconded. The motion passed unanimously (5-0-0).

TOWN ADMINISTRATOR REPORT

Ms. Carreiro read Mr. Hickey's TA report (Attachment C)

Mr. Romano asked if Mr. Hickey or Mr. Furtado could do an update on water issues, he suggested a 1-2page report and asked if it could be included in future bills. Ms. Mello suggested it be the weekly video
subject. Ms. Carreiro will review with Mr. Hickey.

BOARD MEMBER ITEMS / COMMITTEE LIAISON REPORTS

Mr. Saunders reported:

- Marine Resources is reviewing their fees and impacts on revenue. Currently, the number of permits is
 down over the prior year and revenue is at ninety-five percent to the prior two years. They will monitor and
 consider recommendations as needed.
- The Public Safety Complex Committee has a future meeting.

Ms. Mello reported:

Historical Commission met and reviewed projects for the Academy Building that are out to bid; the funds
are from Community Preservation. The Old Stone Schoolhouse had over three hundred visitors and will
reopen in the spring.

Mr. Murphy reported:

• The Veterans Day Parade is tomorrow at 9:00am from Benoit Square. He attended the Veterans' Lunch earlier and thanked Ms. Reed and All Trust Bank.

Mr. Romano reported:

- Thanks to the Recreation Center Director and Assistant for the bingo event, he was a guest caller and it
 was a great event, free and brought in donations of non-perishable items. He also thanked those who
 donated.
- Veterans Day is tomorrow and, in the pledge, we say "all," all means all and our Veterans fought for that.
- SRPEDD met and set a December meeting for the budget.
- Southcoast Places for People led by Will Gardner had a memorial service in honor of those impacted by traffic issues on November 16, 2025
- The Town Meeting Advisory Committee met to review their final report. One big recommendation will be to move Special Town Meeting to a Saturday. There will be a survey sent to Town Meeting Members.

Mr. Silvia had no meetings to report on and thanked Veterans and their families for their sacrifice; this is why we can say what we want.

Thank you for your call this afternoon regarding Mr. Carr's inquiry into my 23 B 3 disclosure I filed with the Town Clerk's Office in regards to the upcoming Planning Board Appointment.

To recap, it seems the question that was raised was why I filed and will be voting for Mr. Jeffrey Lucas, however, in the past I did not file a form and DID recuse myself for appointing Mr. Robert Hannon to a board (be it Zoning or EDC, I can not remember.)

At the time, I did not realize Mr Hannon was seeking appointment to these positions, and I did not have time to call ethics to speak with the attorney of the day (AOTD). In an effort to not bring a question to Mr. Hannons credibility, I recused myself to be safe, especially as Mr. Hannon was not opposed for these positions.

As I had ample time to check in with the AOTD in regards to the upcoming appointment, I have since called and spoke with Mr. Christopher Popov who assured me that as long as there is no financial relationship between myself and Mr Lucas either through the NFIA or through his potential appointment onto the Planning Board, I would be fine and would only need to file a form.

Furthermore, a key difference I feel the need to point out is that Mr Hannon currently serves on the Board of Directors for the NFIA, whereas Mr. Lucas has not attended a meeting in over 2+ years, if not longer. I am happy to provide attendance records. Had it not been for the fact that Mr. Lucas purchased what we offer as a "Lifetime Membership," it is unknown if he would still be a member in good standing. Mr Lucas only occasionally volunteers as a photographer and once a year as a cashier at homecoming and / or the Olde Tyme Holiday Market.

Thank you for taking the time to review this email. I am okay if you would like to forward this along to him. The NFIA is an organization that does endless good for our community, and protecting their name is my highest priority. I have also CC'd Amy Hart and Selectboard Chair Charlie Murphy so they may be aware of my response.

Mr Lucas has not attended an NFIA committee meeting since my membership in April of 2022. In 2023, Mr Lucas was removed as a Board member and now only occasionally attends and participates at our events when we need volunteers. As President of the NFIA, I receive no financial compensation, and neither does Mr. Lucas as a member or previous board member.

How do your official actions or decision matter to the person or organization?	Mr. Lucas is one of the 4 applicants applying for a position on the Fairhaven Planning Board. My decision for who should fill this position is unaffected by my role in the NFIA.

I have no financial or otherwise favors due to Mr. Lucas, the same as I have no influence from the other 3 applicants. Furthermore, despite Mr. Lucas' membership and occasional volunteering at events, we do not interact outside of Town Events as we do not know one another personally.

To the Selectmen/board,

I wanted to bring it to your attention that in the 2024 Community Preservation Plan, it was stated on page 11, that the public had a Polling in 2022 and listed their "primary" concerns were involving cost of housing. This concern remains even greater today, as a well known fact, in 2025.

But when you look at page 47, the last page of this plan, where totals of appropriations are documented, 56% of appropriations went towards historic uses, and a 15% went towards housing needs. And not all of this historic maintenance was even involving buildings that are publicly owned.

Think about this?

Are town hall officials, (be they volunteers or paid positions) really listening to Fairhaven constituents?

Most of the new housing that is being planned and or developed in Fairhaven is \$750,000 and up.

We are still excluding our moderate income earners who offer vital services to the community, and who make up most of our community and population. These people would be police officers, firefighters, nurses, teaches, ambulance drivers/ EMT's, etc..Who no longer can afford to buy a house in Fairhaven. And of course, what about the elderly who cannot find affordable senior housing?

On the first page of this community plan, you are thanking the public for being the majority funding source and who make it possible to have these funds available, and yet their Primary polling concerns are in the lowest percentage of Appropriations. ???

COMMUNITY HOUSING

The CPA statute defines "community housing" as housing for low- and moderate-income individuals and families, including senior housing. "Low-income housing" is for households whose annual income is less than 80% of the area-wide median income (AMI). "Moderate income housing" is for households whose annual income is less than 100% of the area-wide median income. The area-wide median income is determined annually by the United States Department of Housing and Urban Development.

According to the 2024 CPA Affordable Housing Income Limits, the Area wide Median Income for a Family of Four within Fairhaven's Census Area Designation (Providence-Warwick, RI-MA MSA, New Bedford HMFA) was \$91,300. However, for housing units created with CPA funds to be counted toward Fairhaven's 10% affordable housing goal, the units must serve those households whose annual income is less than 80% of the area-wide median income, which the CPA lists as \$73,040 for a family of four.

Fairhaven has some lower-cost market housing units, primarily rental in double and triple decker apartments, but very few of these qualify as countable affordable housing units under State law. In Massachusetts, the term "affordable housing" applies to housing units made affordable to low-and moderate-income households by a recorded deed rider that restricts sale prices and rents in perpetuity to income eligible households.

C. funds may be expended "for the creation, preservation and support of community housing and for the rehabilitation or restoration ... of community housing," but not including maintenance. The Fairhaven Housing Authority historically has been the local agency responsible for implementation of community housing projects.

Community Housing Resources and Needs

During the development of the Master Plan, *Fairhaven 2040* (2017), residents of the Town reaffirmed their commitment to provide affordable housing. In order to retain Fairhaven's community character, it is critical for the Town to encourage and enable a diverse range of resident households to live here. These include municipal and school employees, people who work locally, elderly residents, the adult children of Fairhaven residents, and other first-time home buyers.

The high cost of housing continues to be a major concern of Massachusetts residents. In August of 2022, the Mass INC Polling group conducted a survey on the economic concerns of voters, and the costs of housing and living were their primary issues. Additionally, voters overall supported a shift towards more responsible development and local rent control policies.

In previous polls, such as the UMass Donahue Institute/CHAPA Housing Poll, respondents reported the cost of housing makes it hard to make ends meet; causes them to seriously der moving out of Massachusetts; prevents elderly residents from staying in their town
