1. Assessors: Tax Rate Presentation and Set Rate: Former Assessor Joanne Correia will present details regarding the Board of Assessors recommended 2026 property tax rate. Included in your Board materials is a memo from the Board of Assessors summarizing their recommendation. Below is a summary of the 2025 and 2026 residential and commercial tax rates along with the average single family home property taxes. As you will see, the proposed tax rate has decreased, however the average property tax bill will increase by \$146 annually. That is due to the average home value increasing by \$21,000.

## Residential Exemption

The Select Board may grant a residential exemption to all Class One, Residential properties that are the principal residence of the taxpayer. The Town of Fairhaven has not adopted a residential exemption in the past.

## Small Business/Commercial Exemption

The Select Board may grant a small commercial exemption to Commercial properties that are occupied by businesses with an average annual employment of no more than 10 people and an assessed valuation of less than \$1,000,000. The Town of Fairhaven has not adopted a small commercial exemption in past years.

#### Dear Select Board,

We are writing regarding the agenda item you have told us will be on your Monday, November 24<sup>th</sup> meeting Agenda to "Consider conducting an **External** investigation of the failure of the Town to act on the Timothy-Hiller subdivision plans that were submitted on March 24th, 2025, which resulted in a "Constructive Approval".

If you are not already familiar with the unfortunate circumstances that have resulted in a "Constructive Approval" of the plans submitted by Windmill Acres, LLC for the Timothy-Hiller Subdivision, we would recommend you watch the recording of the last Planning Board meeting.

The history involves an applicant filing for a 16 home subdivision years ago that the Planning Board denied on several occasions. The applicant then sued the Town of Fairhaven and the court system ruled in favor of the Town through every appeal up all the way up to the Superior Court.

While that case was still open in court, the same applicant, Robert Roderiques, formed a new entity called "Windmill Acres, LLC" On March 24th, 2025 the applicant filed those plans at the Town Clerks office. Public records show and statements by current Planning Board member Patrick Carr confirm that he, then Chair Cathy Melanson, Director of Planning Bruce Webb, Select Board member Keith Silvia, Interim Town Administrator George Samia all attended meetings to discuss the submittal of Plans by Windmill Acres, LLC, yet the plans never appeared on a Planning Board agenda prior to the 155 days the Town had to take action, resulting in "Constructive Approval".

The Towns' failure to act, with only a select few being aware of the plans being submitted, allowed a subdivision that the Planning Board rejected several times to then bypass the Towns due process and gain instant approval.


The abutters and neighbors of the Timothy-Hiller subdivision, who were never informed about the subdivision before it received "Constructive Approval" have been irreparably harmed. Trees have been cleared to within a very short distance to the Wastewater Treatment Plant causing greatly increased odors and increased shadow flicker from the Wind Turbines to the existing homes and the new homes will certainly feel the impact more, being that much closer.

#### **Current Status**



Abutters and Neighbors have concern for their own safety as well as the safety of any new homeowner who will live closer to the Wind Turbines given the recent news just weeks ago, on November 9<sup>th</sup>, a blade measuring over 100 feet in length and reported to weigh approximately 9 tons was thrown several hundred feet from a Wind Turbine in Plymouth. This could have killed people.

Just days <u>ago</u> a Wind Turbine blade that was 100 ft long, weighed 9 tons and was thrown 300 feet. It could have killed someone
Wind Turbine blade parts have been documented to be thrown much further.



Kerri Costello lives in a house just a few hundred feet away. "All of a sudden I heard like a huge boom, like an explosion type of boom," she said Friday night. "I don't think I'll sleep though, no I'm not going to sleep."

She is thankful no one, including herself or kids were injured. "Couldn't help but thinking if that was turned a little bit more, it just went over there, I was literally sitting in my room in the window right there, my kids' rooms are in the one right next to it, what if god forbid it ever went through," she said.

"Our biggest fear"

David Daylor lives nearby and says he felt his house shake when the blade fell. "I heard this rumble, and I actually kind of felt it in my house. It felt like a mini earthquake," Daylor said.

The Abutters and Neighbors were never notified about this subdivision before it reached the point of "Constructive Approval" and their comments and questions at the November 18<sup>th</sup> Public Hearing were restricted and limited beyond what the Public Hearing Notice to the Abutters sent by certified mail called for.

Everything about how this project wound up in "Constructive Approval" is exactly the opposite of Open, Transparent and Responsible Town Government by and for the people.

Elected Officials take an oath stating: "solemnly swear that you will faithfully and impartially discharge and perform all the duties incumbent upon them in accordance with the bylaws of the Town of Fairhaven and the laws of the Commonwealth". Town Staff and Town Counsel, paid with public tax dollars owe it to the community to carry out their job functions in the best interest of the community, not in the best interest of any developer. We are looking for anyone and everyone who was involved, in any way, with allowing due process to be bypassed to be held accountable.

Unless the Town conducts a complete and thorough External investigation the Town will not be able to say, with certainty, that any procedural changes adopted to ensure this never happens again are truly addressed.,

We ask that any motion to conduct an investigation on this matter also include language that ensures that the final report that is the product of the investigation will be made available to the public, to the extent permissible by law.

We feel that an External Investigation is the only way to ensure that an entirely unbiased investigation is done.

We wish to preface the following comments by stating that Mr. Hickey, the recently hired Town Administrator has been accommodating and generous with his time with the abutters and neighbors and has addressed concerns about missing documentation online, etc, in a very timely manner. We want to make it clear that we hold nothing against him in this request. However, given the involvement of Director of Land Use and Planning, Bruce Webb, would be a critical part of an investigation and Mr. Webb resigned recently, for reasons that cannot be made public, we request that Mr. Hickey not be part of the investigation with regard to Mr. Webb specifically.

Town Counsel, represented at the November 18<sup>th</sup>, 2025 Planning Board meeting by Ms. Heather White (Petrini & Associates, PC) acknowledged that (given the extensive involvment of Town Counsel in the events leading up to the Constructive Approval), the law

firm would be conflicted in at least some aspects of an investigation on this matter. For that reason, we request that Petrini & Associates not be responsible for conducting any part of the investigation and their only role be to answer questions and provide information requested by the investigator.

Additionally, a line item on the Planning Board agenda for their meeting, on November 18<sup>th</sup>, read as follows; "Executive Session to Executive Session pursuant to G.L. c. 30A, s. 21(a)(7) to comply with, or act under the authority of, G.L. c. 30A, s. 22, to review the minutes of Executive Sessions held on 6/14/2022, 12/13/2022, 2/19/2025, 9/9/2025, 9/23/2025, 10/14/2025 & 10/28/2025".

When the Board reconvened in Open Session, they were asked if those minutes would be released to the public and the answer (given by Town Counsel) was no, with further clarification that none of them will be released at this time.

Massachusetts Open Meeting Law requires "When the purpose for which a valid executive session was held has been served, the minutes, preparatory materials and documents and exhibits of the session shall be disclosed unless the attorney-client privilege or 1 or more of the exemptions under said clause Twenty-sixth of said section 7 of said chapter 4 apply to withhold these records, or any portion thereof, from disclosure.

For purposes of this subsection, if an executive session is held pursuant to clause (2) or (3) of subsections (a) of section 21, then the minutes, preparatory materials and documents and exhibits used at the session may be withheld from disclosure to the public in their entirety, unless and until such time as a litigating, negotiating or bargaining position is no longer jeopardized by such disclosure, at which time they shall be disclosed unless the attorney-client privilege or 1 or more of the exemptions under said clause Twenty-sixth of said section 7 of said chapter 4 apply to withhold these records, or any portion thereof, from disclosure."

Given any meeting minutes that pertain to what lead up to the Constructive Approval would provide valuable insight in an investigation, we ask that the motion for an investigation include release of any meeting minutes and materials that are not expressly covered by the provisions of Mass General Law and that those meeting notes and meeting materials be made available to the public at their earliest availability. We also request that any of the Executive Session meeting notes reviewed on November 18<sup>th</sup> that are not going to be released to the public be listed with a reason why they cannot in part, or in whole, be made publicly available.

Lastly, we ask that Select Board member Keith Silvia recuse himself from any deliberation on this matter given that Public Records show he was involved in several meetings with Windmill Acres, LLC and others, prior to and after the March 24<sup>th</sup> submittal of the plans that resulted in "Constructive Approval" and that he was also involved in meetings to discuss Personnel concerns related to Mr. Bruce Webb, who since resigned as the Director of Land Use and Planning,

We leave you with a quote from Mr. Hickey, our New Town Administrator "If I don't have integrity, I have nothing." We ask that the Select Board consider that message in terms of how it relates to this request for an investigation to fully understand how we landed here, who was responsible and what is the best course of action moving forward.

We look forward to discussing this further with you at your meeting on Monday, November 24<sup>th</sup>.

## Town of Fairhaven Report of the Town Administrator November 24, 2025

#### **Financial Updates**

Department head Capital Improvement Plan requests are due Wednesday, November 26<sup>th</sup>.
 Finance Director Anne Carreiro and I will review the requests and prepare a report for the Capital Planning Committee to begin their review.

#### **Project Updates**

- As a follow up to the comments made at the November 10<sup>th</sup> Town Administrator report regarding water quality, BPW Director Vinnie Furtado has indicated that flushing will be completed prior to the next water and sewer bill being issued this winter and users should notice an improvement in the water quality in being provided. If the water quality has not improved prior to the next water and sewer bill being issued, Mr. Furtado will consider including an explanation of the water improvement project with the billing.
- The ongoing wastewater plant upgrade has caused an increase in the sulfur odor in the vicinity
  of the plant. This increased odor will dissipate in the coming months as the project progresses.

#### Personnel Update

• Interested candidates have submitted their documentation of the Assessor position. Interviews will occur in early December.

#### Miscellaneous Updates

- The Zoning Board will hold a special meeting on December 11<sup>th</sup> to hear an appeal on the building/driveway permits issued on the Windmill Acres subdivision.
- At the Board of Health's November 20<sup>th</sup> meeting, the Board voted to reconsider their prior vote to require the turbines to be shut down for two hours in the morning and another two hours in the afternoon citing the need for verifiable data that supports the health concerns raised by residents in the area.
- The Superior Court dismissed New England Preservation and Development's latest appeal regarding the acquisition of the Rogers School
- The photo contest for the 2025 Annual Report is now open. Please submit no more than two photos to the Select Board's Office electronically by January 7<sup>th</sup> to <a href="mailto:ahart@fairhaven-ma.gov">ahart@fairhaven-ma.gov</a> for consideration.

#### FAIRHAVEN SELECT BOARD Meeting Minutes November 10, 2025

**Present**: Charles Murphy Sr., Andrew Romano, Natalie A. Mello, Keith Silvia, Andrew B. Saunders and Anne Carreiro. **Not Present**: Keith R. Hickey

Planning Board Present: Jessica Fidalgo, Sharon Simmons, Ruy daSilva, Miles Grant, Sean Powers, Kevin Grant and Patrick Carr

Mr. Murphy opened the Select Board meeting at 6:32pm

Ms. Fidalgo opened the Planning Board meeting at 6:35pm and confirmed a quorum was present.

A moment of silence was observed in honor of Veterans' Day.

Mr. Murphy reviewed the process for the joint meeting, interview and appointment. He advised both Boards that Ms. Costen had rescinded her application (*Attachment A*).

#### PLANNING BOARD APPOINTMENT INTERVIEWS (Joint with the Fairhaven Planning Board)

Interview Candidates for one Planning Board Vacancy and Consider appointment.

Candidates: Rick Trapilo, Jeffrey Lucas and Diane Tomassetti

Each candidate addressed both Boards and gave an opening statement.

Mr. Murphy and Ms. Fidalgo asked each candidate the same questions in rotation. At the end of the interview, all candidates were thanked for stepping forward and Mr. Murphy opened discussion to the Select Board and Planning Board.

Patrick Carr addressed both Boards regarding the conflict of interest (COI) disclosure from Andrew Romano and copies of the North Fairhaven Improvement Association (NFIA) attendance from 2022 to present (*Attachment B*). Mr. Carr asked Mr. Romano to recuse himself due to being the NFIA President and the perceived conflict due to Mr. Lucas being a member of the NFIA. Mr. Carr reviewed other examples of conflict of interest disclosures submitted to the Select Board dating back to April, 2025 and referred to Mr. Romano's votes on these matters.

Mr. Romano addressed both Boards about his COI disclosure, the NFIA attendance records that were distributed to both Boards and the summary of his conversation with the State's Attorney of the Day (AOTD) Christopher Popov (*Attachment B*). Mr. Romano said in past meetings he recused himself when a financial relationship existed and he would not be recusing himself tonight.

Mr. Carr asked if Mr. Romano received the opinion in writing. Mr. Romano said he did not. Mr. Murphy added that calls to the AOTD are recorded/documented for reference.

Mr. Lucas asked for clarification on the accusations against him and said that he had not been to an NFIA meeting in over a year due to scheduling conflicts but participates in community events when he can.

**Motion**: Mr. Silvia motioned to appoint Diane Tomassetti to the Planning Board for a term through Town-Elections in June, 2026. Mr. Saunders seconded. Roll Call Vote: Mr. Saunders, Mr. Murphy, Mr. Silvia, Ms. Simmons, Mr. Carr and Mr. daSilva in favor and Ms. Mello, Mr. Romano, Ms. Fidalgo, Mr. K. Grant, Mr. M. Grant and Mr. Powers opposed. The motion failed (6-6-0).

**Motion**: Ms. Mello motioned to appoint Jeffrey Lucas to the Planning Board for a term through Town Elections in June, 2026. Mr. Romano seconded. Roll Call Vote: Mr. Saunders, Mr. Silvia, Ms. Simmons, Mr. Carr and Mr. daSilva opposed and Ms. Mello, Mr. Murphy, Mr. Romano, Ms. Fidalgo, Mr. K. Grant, Mr. M. Grant and Mr. Powers in favor. The motion passed (7-5-0).

**Motion**: Mr. K. Grant motioned to adjourn the Planning Board meeting at 7:19pm. Ms. Simmons seconded. The motion passed unanimously (6-0-0).

The Planning Board adjourned at 7:19pm

Massachusetts Wind Turbines: Harbingers of Death

Massachusetts has had two large wind turbine blade accidents in the past year. The Plymouth blade failure, and at this time last year, the Vineyard Wind blade was still hanging off a turbine. The Vineyard blade spewed 60 tons of foam, fiberglass, and microplastics over a multistate area, ending Nantucket vacations and property values.

The news media, within days of the recent Plymouth accident, reported "experts say" this is a rare event. How quickly the wind advocates, aka the media, forget that over one hundred blades are defective on the Vineyard project. In Massachusetts, blade accidents average one per year.

Reports say it's a good thing Plymouth wind turbines are located in a rural area, and there is nothing wrong with the cranberries in the bog. Massachusetts is the most urbanized state in the US. If the blade had gone in a different direction, it could have killed someone.

Wind turbines in Massachusetts are known as noise machines. Neighbors report sleep disturbance, dizziness, headaches, and stress, which they attribute to the noise and low-frequency sound or infrasound. The Town of Falmouth never disclosed to residen before the installation of turbines that they were warned in writing that the turbines generate 110 decibels of noise.

Both local, state, and federal officials prioritize the Green agenda over the health of residential neighborhoods. The state also does not maintain a dedicated, independent database for wind turbine accidents or safety. The goal of achieving net-zero greenhouse gas emissions by 2050 remains the state's primary focus.


Offshore wind contractors spend hundreds of millions of dollars to get their permits. US taxpayers pay up to 40 percent of the project costs in renewable energy credits and another 10 percent for building ocean wind ports. The expenses incurred by the contractors are not available to the public.

Wind companies pay fines to back out of project power agreements, donations, grants to science/research groups, political contributions, local town events, and media advertising. To put it bluntly, everybody got a bag of money.

One example is that scientists say offshore wind construction does not kill whales, and places that do necropsies never say a whale that is deafened by offshore wind died as a result of offshore wind. The news media never ask these scientists or experts if they or their employers have ever received resources from offshore wind companies. A deaf whale is a dead whale.

It's time to stop the wind turbine insanity. The turbines are intermittent sources of energy requiring high-voltage direct current converter stations, massive battery backup, and fossil fuel power plants.

Massachusetts has 70 land-based wind turbines. It's time for statewide inspections before someone dies.
