### CHAPTER 140 OF THE GENERAL LAWS, TER. ED., WITH AMENDMENTS THERETO (EXTRACT)

Section 57. No person, except one whose principal business is the manufacture and sale of new motor vehicles but who incidentally acquires and sells second hand vehicles, or a person whose principal business is financing the purchase of or insuring motor vehicles but who incidentally acquires and sells second hand vehicles, shall engage in the business of buying, selling, exchanging or assembling second hand motor vehicles or parts thereof without securing a license as providing in section fifty-nine. This section shall apply to any person engaged in the business of conducting auctions for the sale of motor vehicles,

Section 58. Licenses granted under the following sections shall be classified as follows:

Class 1. Any person who is a recognized agent of a motor vehicle manufacturer or a seller of motor vehicles made by such manufacturer whose authority to sell the same is created by a written contract with such manufacturer or with some person authorized in writing by such manufacturer to enter into such contract, and whose principal business is the sale of new motor vehicles, the purchase and sale of second hand motor vehicles being incidental or secondary thereto, may be granted an agent's or a seller's license; provided, that with respect to second hand motor vehicles purchased for the purpose of sale or exchange and not taken in trade for new motor vehicles, such dealer shall be subject to all provisions of this chapter and of rules and regulations made in accordance therewith applicable to holders of licenses of Class 2

Class 2. A person whose principal business is the buying or selling of second hand motor vehicles may be granted a used dealer's license.

Class 3. A person whose principal business is the buying of second hand motor vehicles for the purpose of remodeling, taking apart or rebuilding and selling the same, or the buying or selling of parts of second hand motor vehicles or tires, or the assembling of second hand motor vehicle parts may be granted a motor vehicle junk license.

Section 59. The police commissioner in Boston and the licensing authorities in other cities and towns may grant licenses under this section which shall expire on January first following the date of issue unless sooner revoked. The fees for the licenses shall be fixed by the licensing board or officer, but in no event shall any such fee be greater than \$200. Application for license shall be made in such form as shall be approved by the registrar of motor vehicles, in sections fifty-nine to sixty-six, inclusive, called the registrar, and if the applicant has not held a license in the year prior to such application, such application shall be made in duplicate, which duplicate shall be filed with the registrar. No such license shall be granted unless the licensing board or officer is satisfied from an investigation of the facts stated in the application and any other information which they may require of the applicant, that he is a proper person to engage in the business specified in section fifty-eight in the classifications for which he has applied, that said business is or will be his principal business, and that he has available a place of business suitable for the purpose. The license shall specify all the premises to be occupied by the licensee for the purpose of carrying on the licensed business. Permits for a change of situation of the licensed premises or for additions thereto may be granted at any time by the licensing board or officer in writing, a copy of which shall be attached to the license. Cities and towns by ordinance or by-law may regulate the situation of the premises of licensees within class 3 as defined in section fifty-eight, and all licenses and permits issued hereunder to persons within said class 3 shall be subject to the provisions of ordinances and by-laws which are hereby authorized to be made. No original license or permit shall be issued hereunder to a person within said class 3 until after a hearing, of which seven days' notice shall have been given to the owners of the property abutting on the premises where such license or permit is proposed to be exercised. All licenses granted under this section shall be revoked by the licensing board or officer if it appears, after hearing, that the licensee is not complying with sections fifty-seven to sixty-nine, inclusive, or the rules and regulations made thereunder; and no new license shall be granted to such person thereafter, nor to any person for use on the same premises, without the approval of the registrar. The hearing may be dispensed with if the registrar notifies the licensing board or officer that a licensee is not so complying. Any person aggrieved by any action of the licensing board or officer refusing to grant, or revoking a license for any cause may, within ten days after such action, appeal therefrom to any justice of the superior court in the county in which the premises sought to be occupied under the license or permit applied for are located. The justice shall, after such notice to the parties as he deems reasonable, give a summary hearing on such appeal, and shall have jurisdiction in equity to review all questions of fact or law and may affirm or reverse the decision of the board or officer and may make any appropriate decree. The decision of the justice shall be final.

# FAIRHAVEN SELECT BOARD Meeting Minutes November 24, 2025

**Present**: Charles Murphy Sr., Andrew Romano, Natalie A. Mello, Keith Silvia, Andrew B. Saunders and Keith R. Hickey

Mr. Murphy opened the Select Board meeting at 6:30pm

A moment of silence was observed to reflect on Thanksgiving blessings, remember those lost or who may be facing hardships and to give thanks for the community.

Mr. Murphy congratulated the Fairhaven High School Blue Devils on going to the Super Bowl for a third year in a row.

#### **PUBLIC COMMENT**

Tara Dwelly of John Street addressed the Board with a statement about the constructive approval, failure of elected officials, the importance of being involved in Town affairs and asked for an external investigation regarding the constructive approval of the Timothy/Hiller subdivision.

Kevin Grant of Fort Street addressed the Board as a resident and not as a Planning Board member. He asked for an external, third-party investigation of the Timothy/Hiller subdivision and said the cost to investigate is dwarfed by the potential cost of litigation and people deserve answers.

Jennifer Carter of Paul Street addressed the Board; she is a direct abutter and has many questions on the matter. She is very proud of her neighborhood and asked the Board to vote for an external investigation. Never in the Town's history has a constructive approval happened and it should be investigated.

**Motion**: Mr. Saunders motioned to take item C3 out of order. Ms. Mello seconded. The motion passed unanimously (5-0-0).

#### **ACTION/DISCUSSION**

# Consider Conducting an Investigation for the Failure of the Town to Act on the Timothy-Hiller Subdivision Plans Resulting in a "Constructive Approval"

Mr. Hickey addressed the Board regarding the constructive approval of the Timothy-Hiller Subdivision and apologized for Town staff not bringing this project forward. He has met and spoken with abutters and residents to understand the concerns. Processes have been put in place to prevent something like this from happening in the future. In meeting with the developer, their attorney and Town Counsel, the developer has agreed to additional terms and compliance with as many bylaws as possible.

Mr. Hickey said the Public Works Superintendent has also reviewed concerns about smells from the Wastewater Treatment facility and advised that the smells are due, in part, to the plant upgrade and anticipates a significant decrease by July of 2026 as the work progresses.

Discussion ensued as to how to proceed on the matter, potential outcomes and how the results would be handled, releasing a redacted report, whether action could be taken with elected officials, transparency in any investigation, concerns on future budget deficits of one and a half to four million dollars, Mr. Hickey's time will be focused on the budget and concerns on the overall cost and timeline of an investigation. The Board's consensus was for an external investigation, estimated costs are between six and ten thousand dollars. Mr. Hickey recommended Town Counsel not be involved in selecting an investigator and will report back an estimated timeline.

**Motion**: Mr. Saunders motioned to request the Town Administrator contract to have an external investigation conducted with different outside counsel to determine the sequence of events that occurred from the date the Timothy-Hiller subdivision plans were accepted by the Town of Fairhaven to the date when the plans received

constructive approval due to a Planning Board decision not being made. Ms. Mello seconded.

Bob Espindola of John Street asked the Board to consider not limiting the start date in their motion. Mr. Hickey suggested a revision to the motion. Mr. Saunders rescinded his motion and Ms. Mello rescinded her second.

Motion: Mr. Saunders motioned to request the Town Administrator contract to have an external investigation conducted with different outside counsel to determine the sequence of events that occurred from on or before the date the Timothy-Hiller subdivision plans were accepted by the Town of Fairhaven to the date when the plans received constructive approval due to a Planning Board decision not being made. Ms. Mello seconded. The motion passed unanimously (5-0-0).

#### APPOINTMENTS AND COMMUNITY ITEMS

### **Assessors: Tax Rate Presentation and Set Rate**

Mr. Hickey reviewed the 2026 Tax Rate Presentation prepared by former Assessor Joanne Correia (*Attachment A*). The Board asked clarifying questions about the rate, calculation, proposition two-and-a-half constraints, the average increase residents would see, comparison to the 2025 rate (*Attachment B*), how the Board has voted in the past on the residential exemption and small business exemption.

Discussion ensued about the residential tax shift and that "savings" (slide 3 of *Attachment A*) means a portion is shifted to the commercial rate. Massachusetts' towns' revenue sources like the Cherry sheets are not being given to municipalities at the same proportion and asking the state to use the rainy-day fund interest to help towns because shortfalls will result in cuts to staff, teachers and services.

**Motion**: Mr. Saunders motioned to adopt the shift of 1.75 resulting in a residential factor of 88.38 for 2026. Ms. Mello seconded. The motion passed unanimously (5-0-0).

Mr. Murphy confirmed the Board would not adopt a residential exemption or small business exemption and no votes were taken on them.

#### ACTION/DISCUSSION

#### Consider Member Removal Request: Sustainability Committee: Susan Spooner

Mr. Romano explained the request to remove a member from the Sustainability Committee.

Motion: Mr. Saunders motioned to remove Susan Spooner from the Sustainability Committee. Ms. Mello seconded. The motion passed unanimously (5-0-0).

# Consider Appointing a Select Board Representative for a Hiring Panel for Principal Assessor and Planner Mr. Hickey advised the Board that he is seeking a member or two members to participate in an interview committee for the positions of Principal Assessor and Planner. He clarified it can be one member for both or one for each depending on the Board. Brief discussion ensued about interest.

**Motion**: Mr. Saunders motioned to appoint Andrew Romano as Select Board Representative to the interview committee for Principal Assessor. Ms. Mello seconded. The motion passed unanimously (5-0-0).

**Motion**: Mr. Saunders motioned to appoint Natalie Mello as Select Board Representative to the interview committee for Planner. Mr. Romano seconded. The motion passed unanimously (5-0-0).

Mr. Romano asked if both positions had been advertised and if Land Use Director was changing back to a Planner and Conservation Agent. Mr. Hickey will confirm the job postings and said the Conservation Coordinator is looking at budget impacts of completing training to step into the Conservation Agent role. Mr. Hickey will send the Board the salary and job description changes.

#### **TOWN ADMINISTRATOR REPORT**

Mr. Hickey reviewed his report (Attachment C). The department deadline for submitting Capital Improvement

Plan requests was extended to allow departments to include additional details.

Mr. Romano reminded the Board that he had asked for a follow-up on solar at a previous meeting as a alternative to the wind turbines and advised the Board he would like to attend future Kearsarge Solar meetings with the Town Administrator. Mr. Murphy said the Board did not appear to object but could not vote on this tonight.

Mr. Hickey added that he has asked the Building Commissioner to review his report on the decision and justification of the request from Fairhaven Wind with Town Counsel and confirm next steps.

## FAIRHAVEN SELECT BOARD Meeting Minutes September 30, 2025

Present: Charles Murphy Sr., Andrew Romano, Andrew B. Saunders, Keith R. Hickey and Anne Carreiro

Not Present: Natalie A. Mello and Keith Silvia

Mr. Murphy opened the Select Board meeting at 11:03am

Mr. Murphy explained that this emergency meeting was called due to the expiration of the current Memorandum of Understanding (MOU) for the interim positions of Treasurer and Assistant Treasurer/Collector today. This will ensure continuity for the Town by authorizing the Town Administrator (TA) as Temporary Treasurer until further extension of the two interim positions can be negotiated.

#### **ACTION/DISCUSSION**

#### Authorize Town Administrator as Temporary Treasurer for the Town

Mr. Hickey addressed the Board about the existing MOU between the Town and American Federation of State, County and Municipal Employees (AFSCME) for an Interim Treasurer and Interim Assistant Treasurer/Collector. Labor Counsel recommended the Select Board appoint the TA as the Temporary Treasurer to ensure that business continues until a meeting with AFSCME can be held to extend the MOU beyond September 30, 2025.

Mr. Hickey added that the emergency meeting was needed because not all parties are available to discuss the agreement and appointing the TA as the Temporary Treasurer ensures that there is someone authorized to sign paychecks and bills payable for the Town until a new agreement is signed. The existing agreement was entered into from July 1, 2025 through September 30, 2025 until a new Town Administrator was in place to review and negotiate with AFSCME. Mr. Hickey's first day was yesterday.

**Motion:** Mr. Saunders motioned Pursuant to G.L. c. 41, § 40, which authorizes the Select Board to appoint a temporary Town Treasurer in the event of a vacancy, and pursuant to Section 2 (aa) of the Town Administrator Act, which authorizes the Town Administrator to perform any other duties or tasks assigned by the Select Board, the Board hereby appoints Town Administrator Keith Hickey to the position of Temporary Treasurer, to serve until a successor temporary or permanent Treasurer is appointed by the Select Board. Mr. Romano seconded. The motion passed unanimously (3-0-0).

To The Selectboard,

I was not able to attend the SB meeting on 11/24/25

But I fully supported an investigation into what exactly happened, behind Timothy Street. And I truly appreciate that the SB voted yes to an investigation.

I have a very dear friend who lives on Timothy Street, and I know firsthand what this has done to her and her family. It devastated them.

The 11 acres including a 2 acre wet drainage area that was dug up and chopped down, took all the people on Timothy Street by surprise. None of the people on Timothy Street received a notice in the mail, which is a Massachusetts law that we used to respect and follow.

Truth be told, There are a number of laws that have been broken in this situation, and in many other situations here in Fairhaven, over the last few years, especially.

It appears that breaking the law or ignoring them has become the new normal. And public trust has been lost.

But hopefully with the new TA and TH officials stepping up to do the right thing, will help turn things around here in Fairhaven. And get us back in the right direction.

We are in a deficit, high heating & water bills, the highest we've ever seen. And endless tax increases. Not to mention our community preservation funds being misappropriated, and the highest percentages being sent off to private entities, instead of being used for our community & modest housing needs over the past 8 years.

I was told by a town official that the state of Massachusetts is behind all this over development in dense inappropriate areas. And if that's true, then I think we need to get the Federal government involved, too.

I was also told that we're doing all this developing in the name of housing, but are we really?

When we are developing and bulldozing property that is not prime for housing development, while causing an absolute nightmare for our long standing residents, all in the name of providing homes that will be sold for \$750,000 and up, you can bet you're not doing our community any real favors, because most of the people here in Fairhaven can't afford a house at that price.

So we wreck the lives of the people who have been here for many years, steal their peace, while bringing a new people that can afford those kind of homes, instead of providing 'Affordable homes' in the appropriate areas, for the modest income earners, who offer vital services to our community, and who make up the majority of Fairhaven residents.

Sometimes aiming for profit rather than a healthy cash flow can become a terrible detriment, and end up backfiring as it has, as we see in our town's financial shortages. Robbing Peter to pay Paul.

Residents have witnessed this livable community idea being pushed onto us by the state, but all we have seen is high priced homes and the highest rents we've ever witnessed in our lifetime. Who do they think they're kidding?

Someone needs to step up, a few of our town officials need to step up, and say enough is enough.

There was a \$5 billion dollar housing plan that was passed in August 2024, but no one has witnessed any modest affordable homes being built with that money.

There were supposed to be incentives given to developers to build affordable modest homes, has anyone looked into it?

And what about the USDA, from what it appears now, we don't qualify for rural development modest home building, but we could, we just need to approach them

CPA funds, they can also be used to help our modest housing needs.

And we need to get a real cap on our housing inventory that we already have in stock, and make sure that all these ADU's are not being used strictly for STR profits, because that would be against the bylaws. We have not been following STR bylaws, and we are over our cap amount of 120- That alone has used up much of our housing inventory, and grossly de-stabilized-our housing prices. And priced out our hard working modest income earners from buying a home and having a chance to grow their own equity.

We need to keep doing the right thing, and we need to move forward and get on the right track, we can do it if we stay honest and don't get greedy.

Putting people before profit can create unexpected miracles. Fairhaven has always been a gem of a town. It was never meant to be an overpopulated city, and we still have rural areas/land that we can look into for more home building opportunities.

Thank you again so much, for voting yes at tonight's meeting about having an investigation, and making sure that these people on Timothy Street, who have been so violated, have a fair recompense for their suffering.
