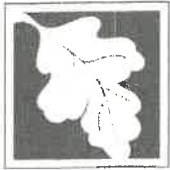

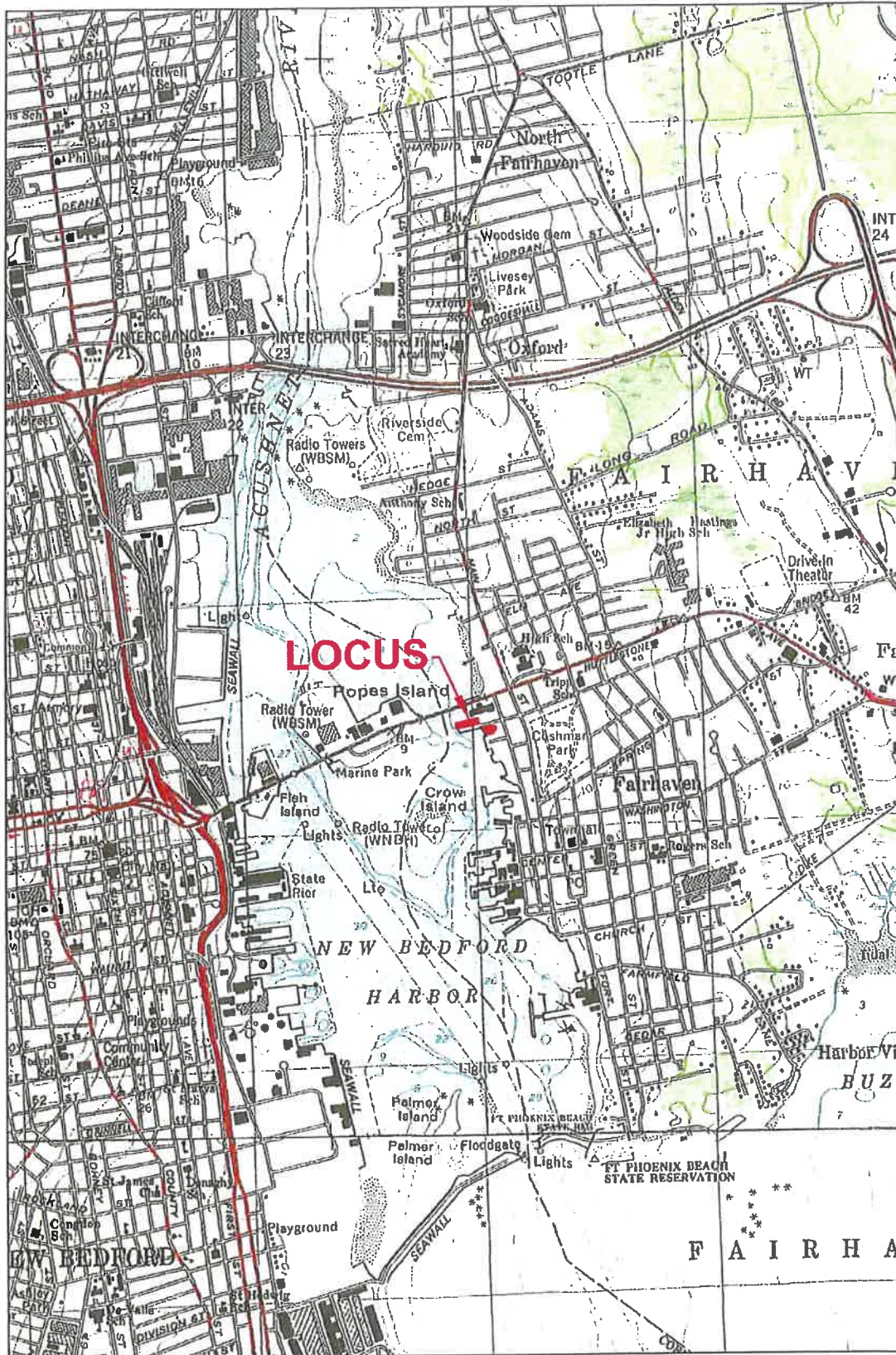

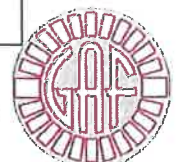
LOCUS MAP

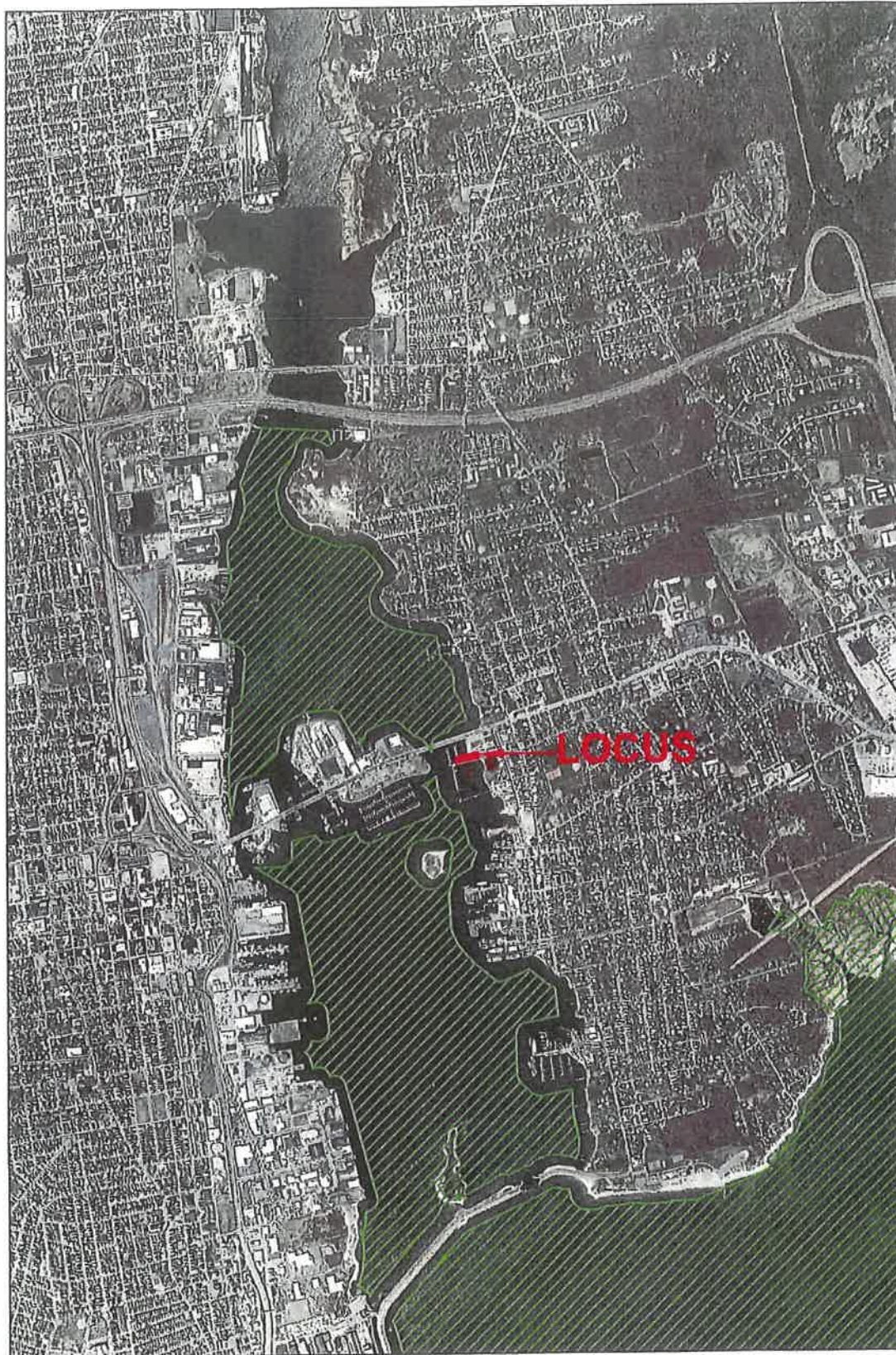
