Background

Year Built: 2007

East Elementary School is located at 2 New Boston Road and provides programs for 300-400 students from preschool through the fifth grade. The building has a lower level, first level, and second level. There is an elevator three (3) staircases connecting all levels.

Exterior locations surveyed included parking, two (2) playgrounds, one (1) swing set, and one (1) recreation area. Interior locations surveyed included the library, the principal's suite, the nurse's office, the cafeteria, the gymnasium, the stage/music classroom, the special education wing, all multi-user toilet rooms, classrooms on the lower level and second level, and single-user toilet rooms in the preschool and kindergarten classrooms.

Key Accessibility Issues

Exterior Routes

Accessibility issues include walkways with slopes that are greater than allowed, walkways that are not maintained in operable working condition, routes with level changes greater than allowed, objects (including tree branches) that act as protruding objects, and lack of an accessible route to a memorial.

Doors and Doorways

Accessibility issues include doors that require opening force greater than allowed, a door with lack of pull side maneuvering clearance due to a shelf, and one (1) door that is recessed deeper than allowed.

Ramps

Accessibility issues include one (1) ramp with a running slope greater than allowed, and handrails with extensions shorter than allowed.

Signage

Accessibility issues include lack of signage with the illuminated International Symbol of Accessibility (ISA) at accessible

emergency egress doors, lack of tactile exit signage at all emergency exit doors, lack of compliant designation, designation signage that is improperly located, designation signage located higher than allowed, designation signage that does not prevent glare, and designation signage that lacks clear floor space due to stored items.

Toilet Rooms

Accessibility issues at the single-user toilet room in the nurse's office include one (1) side grab bar located closer to the rear wall than allowed, and one (1) soap dispenser that acts as a protruding object. Accessibility issues at the single-user toilet rooms in the preschool and kindergarten classrooms include one (1) item located over a grab bar, a side wall grab bar improperly located, and a toilet seat located higher than allowed. Accessibility issues at all boys' and girls' multi-user toilet rooms include doors with malfunctioning self-closing hinges, lack of door pulls, coat hooks located higher than allowed.

Sinks

Accessibility issues include sinks that lack knee and toe clearance due to stored items, and one (1) sink with knee clearance lower than allowed.

Play Areas

Accessibility issues include play areas that lack an accessible route, play areas that lack accessible routes around them, and play areas that lack an accessible route to each play component.

Note: The Massachusetts Architectural Access Board (MAAB) does not consider engineered wood fiber (EWF) to comply with its regulation requiring an accessible route to each play component and around the playground.

- Renovate doors: \$6,000 •
- Renovate signage: \$3,850
- Provide dining and work surfaces: \$7,400
- Provide two (2) picnic tables: \$2,800
- Renovate toilet rooms: \$12,773
- Renovate sinks: \$2,192
- Miscellaneous corrective actions (reach ranges): \$650


*Note: IHCD is not providing costs for accessibility renovations for outdoor areas, ramps or stair handrails. Unit costs are provided for one instance of repetitive items.

Best Practice and Inclusive Design


Best practice and inclusive design recommendations include items that are not required in the standards but may create enhanced experiences for all users.

- Recommend providing a solid and continuous contrasting stripe applied to the edge of the stage for low vision users to see that there is a change in level.
- Recommend providing a solid and continuous stripe applied to the horizontal leading edge of each interior and exterior stair tread so that each tread is readily apparent when viewed in descent at each stair in the building.

- Recommend providing a height adjustable exam table in the nurse's office.
- Recommend repainting the crosswalk between the passenger loading zone and the path to the basketball court.
- Recommend providing a clear floor space alongside one bench in each area where benches are provided that does not exceed a slope of 2.00% surface at least one bench, positioned to allow a person in a wheeled mobility device and a person sitting on the bench to have their shoulders aligned. See the following diagram:



- Recommend using term "Accessible Parking" instead of "Handicapped Parking".
- Based on a comment from the Commission on Disability, recommend providing adaptive play and sport equipment.
- Recommend providing a stable, firm and slip-resistant surface that is 48" clear on all sides of the accessible picnic table in each location in a manner similar to the following diagram:



Recommend providing a directional sign to the classroms within the special education wing at the entrance.

 Recommend providing an additional tactile designation sign alongside the right cafeteria entrance door for cases when the right door is propped open, as was seen during the survey. Recommend placing additional designation signage for the boys' and girls' multi-user toilet rooms on the tiled walls.
