Background

Livesay Park is located at 305 Main Street. Park amenities include basketball courts, pickleball/tennis courts, two (2) softball fields with team seating areas, one (1) football field, two (2) playgrounds, one (1) skatepark, one (1) skating rink, and two (2) single-user toilet rooms. There are two (2) parking areas – one on the northwest side located within the park, and one on the west side a shared parking lot with the apartment complex.

Key Accessibility Issues

Exterior Routes

Accessibility issues include routes with excessive level changes and excessive running slopes.

Parking

Accessibility issue includes lack of an identification sign with the International Symbol of Accessibility (ISA) and the designation "Van Accessible" at the van accessible parking space in the west parking lot.

Signage

Accessibility issues include lack of tactile designation signage at the men's and women's single-user toilet rooms.

Toilet Room

Accessibility issues include lack of a compliant door locks, plumbing underneath lavatories is exposed, and one flush control is not on the open side.

Areas of Sport Activity

Accessibility issues include lack of an accessible route to the boundary of activity (softball, skate park, pickleball court)
Additionally, there is a lack of an accessible route to team seating areas and sideline seating areas, lack of an accessible space in softball team seating areas, and lack of accessible spaces at sideline seating areas in the east softball field and football field.

Playgrounds

There is a lack of an accessible route to and around each playground and lack of a compliant impact-attenuating surface to the play components.

Note: The Massachusetts Architectural Access Board (MAAB) does not consider engineered wood fiber (EWF) to comply with its regulation requiring an accessible route to each play component and around the playground.

Additional Accessibility Issues

Lack of an accessible picnic table.

Order of Magnitude Cost Estimates

Provide van designation signs: \$1,000Provide signage at toilet rooms: \$900

Provide an accessible picnic table: \$1,400

Renovate toilet rooms: \$3,286

Total: \$6,586*

*Note: IHCD is not providing costs for some exterior issues such as estimating the cost to repair or provide expanses of sidewalk and walkways.


Best Practice and Inclusive Design

Best practice and inclusive design recommendations include elements that are not required in the standards but may create enhanced experiences for all users.

• Recommend providing a 36" min. by 48" min. stable, firm and slip-resistant surface adjacent to at least one of the existing benches in each unique program area in the park in a manner that is substantially similar to what is shown in Figure 1.

Figure 1 shows a stable, firm and slip-resistant surface adjacent to a bench positioned to allow a person in a wheeled mobility device and a person sitting on the bench to have their shoulders aligned:

 Recommend locating all accessible signage in the northwest parking lot with the bottom of the sign no lower than 60" above the ground.
