### **Background**

The Southeastern Massachusetts Education Collaborative (SMEC) building is located at 56 Bridge Street. The building has one floor where programs are offered to members of the public, and there are two (2) accessible entrances. Amenities include a nurse's office, a sensory room, a social worker's office, an assembly space, two (2) classrooms, and a kitchen. Programs at the SMEC include transitional service programs for students with disabilities, ranging from 14-21 years of age.

Exterior locations surveyed included the parking lot and routes to and around the building including to both accessible entrances. Interior locations surveyed included the nurse's office and the allgender, single-user toilet and shower room inside the nurse's office, the sensory room, the assembly space, both classrooms, the kitchen, and the men's and women's multi-user toilet rooms.

**Note:** IHCD team was told that the all-gender single-user toilet room is not used by students or other members of the public. If that is the case, that toilet and shower room does not have to be made accessible. However, we included accessibility recommendations for that toilet and shower room in case it is used by students or other members of the public now, or will be in the future.

### **Key Accessibility Issues**

#### **Exterior Routes**

Accessibility issues include running and cross slopes steeper than allowed, surface openings greater than allowed, level changes higher than allowed, routes not maintained in operable working condition, and one (1) object that protrudes into the circulation path.

#### <u>Parking</u>

Accessibility issues include the lack of two accessible car parking spaces. The accessible van parking space also lacks a compliant parking identification sign with the International Symbol of Accessibility (ISA) and the designation "Van Accessible", and the parking spaces have a slope that is greater than allowed.

#### **Exterior Ramp**

Accessibility issues at the north exterior ramp include a cross slope greater than allowed, lack of one (1) handrail, a handrail that lacks extensions on the top and bottom of the ramp, and lack of edge protection on one side of the ramp.

#### <u>Stairs</u>

Accessibility issues include lack of handrails provided on both sides of staircases, and handrails that lack extensions. There is also one (1) staircase with riser heights that are not uniform.

#### Interior Routes

Accessibility issues include one (1) route with a cross slope steeper than allowed, one (1) route with a level change steeper than allowed, routes narrower than allowed due to the location of stored furniture, and one (1) object that protrudes into the circulation path.

#### Doors

Accessibility issues include doors that lack maneuvering clearance, and doors with noncompliant hardware that can't be used without tight grasping, pinching or twisting of the wrist.

#### <u>Signage</u>

Accessibility issues include the lack of tactile exit signage, lack of signage with the illuminated International Symbol of Accessibility at accessible egresses, designation signage that is improperly located, and one (1) room that lacks a designation sign.

#### **Assembly Areas**

Accessibility issues include the lack of an accessible route to the stage and lack of an assistive listening system in the main assembly hall.

**Note:** If audible communication is integral to the use of the space, an assistive listening system shall be provided as shall a sign with the International Symbol of Access for Hearing Loss.

#### Kitchens

Accessibility issues include the lack of a cooktop with knee and toe clearance, lack of a wall mounted oven, and one (1) sink with

Southeastern Massachusetts Education Collaborative (SMEC) knee and toe clearance lower than allowed and the rim of the sink located higher than allowed.

#### **Toilet Rooms**

Accessibility issues in the men's and women's multi-user toilet rooms include toilet compartments narrower than allowed, lack of rear grab bars, side grab bars shorter than allowed, toilets located farther from the side wall than allowed, improperly located toilet paper dispensers, and coat hooks located higher than allowed. There are also lavatories with exposed plumbing, a lack of clear floor space due to stored items, and mirrors located higher than allowed.

Accessibility issues in the all-gender single-user toilet room in the nurse's office include the lack of the minimum required turning space, lack of accessible plumbing fixtures, lack of an accessible shower compartment, and coat hooks are located higher than allowed.

**Note:** IHCD team was told that the all-gender single-user toilet room is not used by students or other members of the public. If that is the case, that toilet and shower room does not have to be made accessible. However, we included accessibility recommendations for that toilet and shower room in case it is used by students or other members of the public now, or will be in the future.

#### **Additional Accessibility Issues**

- An object (paper towel dispenser) located higher than allowed.
- Lack of one (1) accessible dining and / or work surface in the kitchen area.
- Lack of one (1) accessible picnic table located on an accessible route.

- Miscellaneous corrective actions (cane-detectable barrier,



\*Note: IHCD is not providing costs for exterior issues such as estimating the cost to provide and repair walkways, ramps, and staircases.

### **Best Practice and Inclusive Design**

Best practice and inclusive design recommendations include items that are not required in the standards but may create enhanced experiences for all users.

- Recommend providing a height-adjustable exam table in the nurse's office.
- Recommend providing adjustable lighting in the sensory room.
- Recommend providing a solid and continuous stripe applied to the horizontal leading edge of each exterior stair tread so that each tread is readily apparent when viewed in descent at this exterior stair. Recommendation applies to all interior and exterior stairs that lack visual contrast on the stair nosings.
- Recommend providing a stable, firm and slip-resistant surface that is 48" clear on all sides of accessible picnic tables in a manner that is substantially similar to what is shown in the following image:
