While normally the full committee would review prior to submission, the DPW was against an early January deadline. Likewise, this committee has discussed and shown support for the initial stage of this</p>

			<p>project in the past.</p> <p>The DPW also asked for a letter of support for a grant for intersection work on Sconticut Neck Road/Manhattan Ave. I (Will) did not feel comfortable providing a letter of support on behalf of the committee. The committee has not discussed this proposed work, nor was it involved in determining what street safety projects to prioritize.</p> <p>I have related to the DPW that, in order for us to be able to support projects in the future, this committee must be involved at the initial vision/values/priorities stage of planning (not just brought in later for public input).</p>
